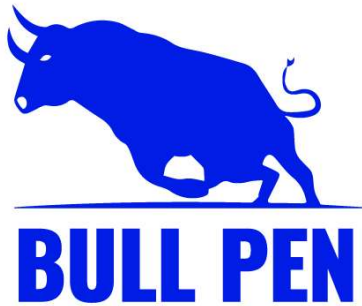




SAMPLE 2023 Bull Pen Application intended to familiarize applicants with application questions. Statement confirmations, questions and supporting documents highlighted in **RED** are required and must be properly affirmed, answered or uploaded. Discussion questions are limited by the number of words for each response; word counters (ex. 0/120) included. Uploaded attachments are limited in file size to 10MB each. The actual application requires an electronic signature. The actual application may be saved, edited and printed before submitting it on-line via Jotform.com. An application cannot be edited once it has been submitted.



2023 Virginia FAIRS Agriculture and Forestry Innovation Challenge "Bull Pen" Application

Welcome to the application for the **2023 Virginia FAIRS Agriculture and Forestry Innovation Challenge**, referred to herein as the "**Bull Pen**". The Bull Pen is a statewide business competition for Virginia entrepreneurs who are addressing issues affecting Virginia farmers, forest landowners and rural communities. Up to five finalists will be selected from among all eligible contest entries. These five businesses will compete live November 27 – 28, 2023 during the 2023 Virginia Farm Bureau Federation Annual Meeting at the Virginia Beach Convention Center in Virginia Beach, Virginia.

By the conclusion of the Bull Pen, the Virginia Foundation for Agriculture, Innovation and Rural Sustainability will have awarded up to \$30,000 in startup funds to the Bull Pen winner and finalist businesses. Each finalist will receive a \$2,500 prize. The second-place entry will receive an additional \$5,000 prize. The overall winning entry will be awarded an additional \$10,000 prize. All finalists are eligible to compete for an additional \$2,500 People's Choice award.

The content of the application and required additional information will be used to compare all Bull Pen applications during Round 1 judging to determine the 2023 Bull Pen Finalists.

To apply for the 2023 Virginia FAIRS Agriculture and Forestry Innovation Challenge "Bull Pen", complete and submit this application form and required supporting entry materials no later than **September 15, 2023 at 11:59 pm EDT**. *Applicants may save and print both draft and final versions the application; however, you may only submit one final application per account. You must be able to affirm items 1 thru 7 below to complete this application.

REQUIRED *

1. You must be at least 18 years of age as of September 15, 2023 to be eligible to compete in The Bull Pen. I (team lead) am at least 18 years of age.

REQUIRED *

2. Businesses eligible to compete in The Bull Pen must be for-profit. Non-profit businesses are not eligible. I certify that the startup I am representing is a for-profit business.

REQUIRED *

3. Businesses who have received a funding round beyond Series A are not eligible to compete in The Bull Pen. I certify that the startup I am representing has not received funding beyond a Series A offering.

REQUIRED *

4. Previous Bull Pen winners are not eligible to compete in The Bull Pen for the same business idea. I certify that I understand the business idea I am representing is not eligible to compete in The Bull Pen if it is the same as one my business' has previously entered and won the Virginia FAIRS Agriculture and Forestry Innovation Challenge.

REQUIRED *

5. I understand that if I am selected as a Finalist business, I will be required to provide content for various types of communications pieces, about my business solution, and my experience competing.

REQUIRED *

6. I understand that if I am selected as a Finalist business, I will be required to compete live in-person at the Virginia Farm Bureau Federation Annual Convention November 27-28, 2023, in Virginia Beach, VA. (Virginia FAIRS will provide hotel accommodations and up to three meals for up to two team members.)

REQUIRED *

7. I hereby certify that all statements I have made made, and information provided in this application are true and accurate to the best of my knowledge. I understand that a false statement will disqualify me from the competition.

Video Pitch

Applicants must submit a three-minute or shorter video pitch for your business or business idea. Videos will be shared with the public. Do not include any confidential information in your video. Submitted videos will only be used for Bull Pen presentations and promotion.

Video Guidelines:

- You must own the rights to any video you submit.
- Do not include images of recognizable people who are not affiliated with your business unless you have their written permission.
- **Video Format**
 - Length - Maximum of 3 minutes
 - Aspect Ratio - 16 X 9, filmed horizontally
- **Video should address these items**
 1. Introduce your team and share your story of how and why you started your company.
 2. Provide an overview of your business.
 3. Describe the challenge affecting farmers, foresters and/or rural communities that your business will address.
 4. Explain why you should be the Bull Pen Winner and how winning this competition will impact you/your business.

Upload your video to YouTube as a **non-private** video. You can designate the video as "Unlisted" if you wish but be sure the video is not "Private". *Your video will be shared with the public. Do not include any confidential information in your video.*
